IN EARLY 2014, HFSV WENT INTO LATINO NEIGHBORHOODS AND ASKED FAMILIES TO PARTICIPATE IN A SURVEY, A PROJECT THAT GENERATED OVER 2,000 RESPONSES. THE RESULT OF THIS WAS THE VOICES OF CHANGE REPORT PUBLISHED IN LATE 2014. THE REPORT INDICATED THAT 40% OF THE PARTICIPANTS PLACE EDUCATION AS THE MOST IMPORTANT CHALLENGE, AND INCREASING YOUTH PROGRAMS TO PREVENT STUDENT DROPOUTS IS THE SOLUTION.
